



## Minutes of the Steering Group Meeting, Oslo, 10-12 June 2010

### 1. Adoption of minutes

The minutes of the previous meeting, in Washington DC in October 2009, were approved by e-mail consultation and posted to the website in advance of this meeting.

## Reports from the Coordinating Groups

### 2. Report from the Social Welfare Group

See attached report.

There are several reviews in the pipeline, but progress is slow and the group needs more resources in order to stay on top of the work. There is a great need for more managing editor time. The group could use more funds, but it is difficult to find the time to apply for funding. Several solutions to the need for editorial capacity were suggested, such as hiring a graduate student to do the managing editor work, or having a full time shared managing editor across groups.

The managing editor only has one day a week for editorial work, and is also co-authoring reviews. We need to codify what to do in the situations where someone has a dual role in the review process, as it arises regularly.

Co-registration procedures with Cochrane work well. The authors decide which group is primary, and there are no problems with publishing in Wiley. The updated agreement on co-registration was circulated.

The group is working with developing internal FAQs to have standardized answers to recurring questions. This work also requires resources. It would be a good idea to make this information available through the Toolbox eventually.

There is cooperation with the Cochrane/Campbell Developmental, Psychosocial, and Learning Problems Group. However, since their coordinator has left, they are not in a position to publish as much. Aron Shlonsky will contact Geraldine MacDonald to discuss what can be done to support her.



Last year it was agreed in principle with the Joanna Briggs Institute in Australia that we could co-register reviews. We should follow up this contact as they have particular expertise in synthesizing qualitative data. Eamonn Noonan will look into arranging a meeting with them.

### **3. Report from the Crime and Justice Group**

There are 25 completed reviews, including 6 in the last year. There are 32 reviews in progress. 15 of these are past the protocol stage, and there are 17 protocols in progress.

The National Policing Improvement Agency (NPIA, UK) has provided additional funding of \$142,500 in addition to the \$420,000 provided last year for four systematic reviews and two systematic searches. This will support the development of one of the systematic searches funded last year into a full review, as well as a new systematic review on macro-level crime displacement. A mini conference was organized in the UK in March that brought all the authors together to present preliminary findings.

The 10<sup>th</sup> annual Jerry Lee Symposium on Crime Prevention was held in the Washington DC area in April. The event mainly attracts academics, but also some policy makers. It features Campbell reviews in the second part of the day.

There are changes on the Steering Committee: Martin Killias will succeed Peter Grabowski as co-chair. David Weisburd will stay remain as co-chair until November 2012 and will be succeeded then by David Wilson. The Steering Committee meets twice a year. Charlotte Gill has now moved to George Mason, and will continue as managing editor. Funding for her position is in place for the next year.

Funding opportunities seem to be improving in the US.

### **4. Report from the Education Group**

See attached report.

The new Co-chairs for the Education Group, Paul Connolly and Gary Ritter, led a discussion on revitalizing the group, on capacity building and on fundraising ideas.

On the restructuring of the group, it was pointed out that uniformity across groups within Campbell is not necessary, but it is recommended to have a Steering Committee. The bylaws of the SWCG were mentioned as a template.

Paul Connolly suggested that he can look into funding opportunities at [improvingchildrenslives.org](http://improvingchildrenslives.org), an interdisciplinary research initiative at Queen's University, of which he is the director. There are partners in Northern Ireland and Scotland. One option is to look into core funding for one or two posts. Review teams can then be assembled to do reviews of relevance to them.

The scope of the group includes work on broad policy questions.



## **6. Report from the Methods Group**

Since December 2009 15 protocols and draft reviews have been submitted for methods reviewing. Terri needs a Co-editor as she is currently writing all action letters. Can someone on the European side be identified? There has been a change in leadership in the Economic Methods Group.

## **7. Report from the Users Group**

Vivian Leacock attended on behalf of Gill Clark. As of March 2010 there are 38 completed User Abstracts. 10 User Abstracts are in production. Vivian Leacock argued for reviewers to themselves write the User abstract, also in order to get researchers to think more closely about communication with users.

## **Production of reviews**

### **7. Revision of policy briefs**

#### Information Retrieval policy brief

A new Information Retrieval policy brief has been drafted, written by Karianne T. Hammerstrøm and Anne Wade. Comments have been received from peer reviewers.

*Decision: Karianne Hammerstrøm is asked to revise the Brief in the light of the comments received. Once this has been done, the Steering Group will vote on approval of the document.*

#### Policy briefs

Mark Lipsey is taking the lead on this, in consultation with the Editors of the thematic groups and a Co-chair from each Coordinating Group.

The aim is to have a single policy document, rather than several. This should include templates for titles, protocols, and reviews incorporating Campbell's policies. This should be a short document, compared to what we have now, with links to more elaborate background texts. We need to first decide on a central policy document, and then decide what resource material we want to refer to.

*Decision: Mark Lipsey will work on what should go into this central document and circulate ASAP.*

### **8. Streamlining the production of reviews**

#### Double role – editor and author

It was agreed that standardized procedures should be drawn up for situations when an editor is also a member of a review team. The current practice of the Education Group was mentioned as a good interim solution; Sandra Wilson asks another group to do the editing when she is also an author.

#### Editorial capacity and an increasing volume of work



Editorial capacity is increasing output is a priority. There is a particular problem with recruiting peer reviewers. It was agreed that there is a need to recruit and train additional editors (see next paragraph).

#### External methods review for protocols

*The SG agreed to a proposal that the external methods review of a draft protocol may be dropped, if and only if the methods editor considered this to be superfluous.* There will still be an internal methods review of protocols, and both an internal and external methods review of draft reviews. It was also agreed that an Associate Editor should be identified to assist Terri Pigott with routine screening. This is also a way to plan for succession.

#### Users group involvement

The SG discussed ways to better involve users in the review process. It is especially important to involve users at the outset, in identifying topics etc, and at the dissemination stage, when research results are being communicated. At the moment, the users group is not set up to provide for user involvement, and there are no resources to cater for it. It was suggested that policy makers and practitioners be invited to give comments and input when new protocols are posted.

#### How to handle fast track reviews

The SG discussed how to deal with reviews which are subject to strict delivery deadlines. One proposal is to set up a standing committee of people ready to work on such reviews. The details of this would however need to be worked out.

*The SG decided that the Editors should arrange a conference call and prepare a memo with proposals on streamlining work processes.*

### **9. Co-registration of reviews**

Through an agreement with the Cochrane Collaboration/Wiley, co-registered reviews may be freely published in the Campbell Library.

Co-registration agreements involve the respective groups in Campbell and Cochrane, as distinct from the two Collaborations themselves.

*Decision: The co-registration agreement between the Social Welfare Coordinating Group and the Cochrane Public Health Group was endorsed and recommended as a possible model for other groups.*

### **10. Developing the resource centre**

The Resource Centre is to be developed further. Head Office welcomes input, both on content and on suggestions for structural improvements.

## **Dissemination**

### **11. Campbell systematic reviews as an online publication**



Since the previous Steering Group meeting, we have gathered permission to publish forms both for protocols and reviews. There is a recent instance of a journal refusing to publish an article on the grounds that the review had already been published in our online library. It is important in this context to emphasise that Campbell Systematic Reviews is a monograph series rather than an online journal as such. While the publication policy of journals varies, there are journals that routinely publish articles based on Campbell reviews; indeed, there are journals that will do so without further external refereeing. As we have moved towards a more formal publication status, there will be some tradeoffs. There is however significant benefit in having a recognized publication of our own.

## **Networking**

### **13. Keystone**

#### **a. Status of the Colloquium programme**

People who are registering should do so before the early registration deadline at the beginning of July. It is important to ensure a range of topics on the conference programme, including in the areas of education and of crime and justice. Currently there are 102 workshops registered, and there is some spare capacity.

Meetings: The Education Coordinating Group should book a meeting. This and other meetings should be arranged through the Colloquium website.

Promotion: We will continue to promote the Colloquium to Campbell constituents. A short note for use by SG members to this purpose will be circulated.

- Possible participants from the four states area should be identified and informed of the event.
- Vivian Leacock will explore some state government contacts in Denver.
- Mark Lipsey has contacts in the area. Will send information to relevant government agencies.

#### **b. Campbell Collaboration Awards**

The nominations for the Boruch and Mosteller Awards were discussed. In view of the high quality of the nominees, it was decided to carry nominations over to next year.

*Decision: The SG voted on the two prizes by secret ballot. It agreed that the votes would be counted and the winners announced after the end of the meeting.*

### **14. Partnerships**

#### **a. 3ie / Proposal to establish a Lower and Middle Income Countries Coordinating Group**

The SG discussed a proposal to establish a coordinating group for reviews concerning Lower and Middle Income Countries. Howard White, Director of the International Initiative for Impact Evaluation (3ie), was invited to introduce this item.



John Arne Røttingen, Director of the Norwegian Knowledge Centre for the Health Services, was also invited for this item. He took the opportunity to note that the work of Campbell since the head office moved to Oslo had been rewarding for the Knowledge Centre, and confirmed that the Centre was happy to continue to host the head office. He noted the importance of translating knowledge and putting research into context, as distinct from the work of conducting a systematic review. He stressed the continuing need for research on topics which are directly relevant to Norway.

There is growing international interest in systematic reviews on development issues, as evidenced by a recent initiative by the UK's Department for International Development (DFID). Following a call for proposals earlier this year, a number of systematic reviews will now be funded, and are intended to be completed this year. 3ie itself has commissioned systematic reviews, though its main focus is support for primary studies involving impact assessment.

It is proposed to set up a coordinating group that will handle reviews on development issues. It was emphasized that this group will be a Campbell Collaboration entity, subject to the same guidelines as the existing groups.

One key question concerns the process of setting up a coordinating group, and the need to maintain an equitable threshold. This will be the first new Coordinating Group since the establishment of the Collaboration. It will therefore be a model for further expansions. It was pointed out that an inaugural meeting should be convened in order to elect co-chairs and approve a governance plan and a plan of work. An editor or editors should also be nominated, for approval by the SG. It was suggested that the DFID workshop planned in connection with the newly commissioned reviews would be a suitable venue for an inaugural meeting. Following the inaugural meeting, the Steering Group would need to decide on the consequent amendments to the Collaboration's Governance Plan, for example on SG membership. This will in effect be a decision on the ratification or not of the new group.

3ie is in a position to support an editorial position located within their new office in London.

The need to maintain standards, not least in relation to inclusion criteria, was emphasized. In this context it was confirmed that reviews through this group will be handled in the same way as all other reviews, and will include a methods review.

The need to consider the use of qualitative data and to find suitable strategies for this was emphasized.

The need to nurture new reviewers and to build competence was noted. It is important not least to ensure involvement of researchers in Lower and Middle Income Countries.

*Decision: The SG agreed that preparatory work should continue, with a view to a decision on the matter by the SG at Keystone. In the event of rapid progress, a vote may also be arranged electronically before the October meeting.*



*Head Office is asked to write to DFID to inform them of our engagement in this area, and to point out the Collaboration's possible role in a wider effort to support more rigorous impact assessment in a development context.*

#### **14 b. SFI Campbell**

Campbell now has a memorandum of understanding with SFI Campbell in Copenhagen. SFI Campbell is now more strongly focused on the production of reviews. There are currently 14 reviews in progress.

#### **15. Update from Cochrane Collaboration**

Nick Royle reported on developments in the Cochrane Collaboration. A notable innovation is that the Cochrane Library has moved from quarterly to monthly publication. 50-60 new or substantially updated reviews are published each month. Changes have been made to the Cochrane Library website, to improve accessibility. The 2011 Cochrane Colloquium will be held in Madrid. The Canadian Cochrane Centre has been awarded a \$9.5 million grant by the Canadian Institutes for Health Research.

A joint session of the Campbell and Cochrane Steering Groups is planned for Denver in advance of the Joint Colloquium. Possible agenda items include: Issues faced by both Collaborations; co-registration; demarcation issues. The format will be an open discussion, as opposed to a decision point.

#### **16. Colloquium 2011**

The SG discussed possible formats and possible venues for the Campbell Colloquium in 2011. There was support for the idea of a smaller, more focused event. A training workshop and engagement with practitioners and decision-makers are important components. Alongside a scaled down event, we should aim to have Campbell- organized panels at relevant conferences in our areas of interest.

*Decision: An ad hoc committee including Terri Pigott, Jeff Valentine, Arild Bjørndal and Eamonn Noonan is invited to follow up the options mentioned and to submit suitable proposals.*

## **Administration**

#### **17. Secretariat report**

See attached report.

It is expected that the Norwegian investment will continue, but it is not yet clear whether this will be at a higher or lower level than at present. This means that it is not yet sure that we will be able to continue to provide the same level of support from Oslo to editorial and other activities. A proposal that may significantly expand funding is however also on the table, and if adopted will improve our position. In any event, it remains critically important to produce and to disseminate reviews that are relevant for Norway, and to contribute to capacity building in systematic reviewing in Norway.

It is also important to examine funding opportunities elsewhere, for instance from the European Union.

**18. Review of the Governance plan**

It was agreed to defer discussion of possible revisions to the Governance plan.

**19. Any other business**

It was agreed that Coordinating Group Editors are welcome to attend future Steering Group meetings. Head Office is invited to examine whether funding can be provided.

**20. Next meeting**

The next meeting will be in connection with the Keystone Colloquium in October. We will meet in Denver on Sunday 17 October (from 9 am to 5 pm; transfer to Keystone at 6 pm), in Keystone on Monday 18 October (morning) and on Tuesday 19 October (following the Jerry Lee Lecture and Reception). A joint session with Cochrane's Steering Group will take place during the morning session on Sunday 17 October.



## Appendix 1: Report from the Social Welfare Group

### **Social Welfare Coordinating Group (SWCG) Report to the Steering Group June 2010**

*Status of Reviews, Protocols, and Titles (see attached report for details)*

To date, the SWCG has entertained 107 distinct titles for C2 reviews in the fields of social welfare. We have received multiple documents for most of these titles. 30 reviews are complete, and 55 are underway. 26 protocols are in progress, as are 12 new titles. 22 titles are inactive

The Cochrane/Campbell Developmental, Psychosocial, and Learning Problems Group (CDPLPG) is responsible for editorial work on 28 of the completed reviews, 7 approved protocols, 3 approved titles, and 3 title in progress. Of these, 11 were initiated in Cochrane by CDPLPG on behalf of both Collaborations, 6 originated in C2 and 3 were referred to CDPLPG.

3 SWCG reviews were co-registered with other Cochrane groups, one with Public Health, one with EPOC, and one with Drugs and Alcohol. In addition, we share several titles with the C2 Education and/or Crime and Justice groups, with the editorial base in the SWG.

*Aspirations and Goals for the coming 2-5 years (first introduced in May 2009)*

1. Expand editorial base and speed up editorial process.

Progress:

William Turner is doing an exceptional job in terms of editing and Krystyna Kowalski continues to work 1 day / wk as Managing Editor and does all she can. However, we are in a holding pattern in terms of improving our responsiveness and organization. Until we can get a good managing editor who devote half-time to this group, preferably housed at Bristol with William, we are unlikely to improve our process. This has fairly strong implications for our productivity.

2. Develop a start-up pack for new authors to take them through the process of conducting a review – start to finish. This will be a web-based document with hyperlinks to necessary forms, sections of the C1 handbook, and our own internal FAQ. Work on this goal may now be possible with the new toolbox.

Progress:

The toolbox may now be operational, so we can begin this process. However, progress is unlikely without an increase in Managing Editor time.



3. Work with Bjorn Tommy to develop a tracking system for reviews, complete with prompts for action on our part and on the part of authors. We are, basically, in the dark ages in terms of keeping track of our ever-growing number of reviews, and our problems will be compounded when considering updates. We need a system, like Archie, that has 'ticklers' to inform us when things need to be done. We are awaiting an update from Bjorn Tommy so we can plan next steps for this goal.

Progress:

We are awaiting the next installment of the toolbox.

4. Develop online training courses in concert with the methods group that takes authors through each stage of the review process and introduces them to all of the resources at their disposal. We see this as a more substantial community development initiative than the interest groups.

Progress:

None to date. This is a fairly large job. Paul and I would like to do it, but need help organizing people and dates. We simply do not have time to organize these sessions. Perhaps we can get some administrative assistance from the secretariat?

5. Seamless co-registration process with all appropriate C1 groups. Substantial steps have been taken with this goal. We are now in the process of finalizing co-registration procedures and documents with C1 public health, and this will serve as a template for co-registration with other groups.

Progress:

Public Health guidelines have been completed and these are being used as a template for all other C1 groups. No information on how it's working as of yet, but we should have more information in the coming year.

6. Development of internal FAQ so editors and managing editors can access ready-made responses to frequently asked questions. Also serves as an online form of institutional memory. This goal will not be met without increasing the hours of the managing editor.

Progress:

Still on hold due to time constraints of the Managing Editor

7. Develop capacity to respond quickly to current media events by highlighting relevant reviews. Again, this must be a concerted effort from the group that requires additional managing editor time. We can go in a number of different directions, but all require an administrative inside person.

Progress:

Great idea, but again requires somebody's time



## **Current Issues, Information, and Events**

### *Keystone Conference*

Paul, Aron, and Julia have been fairly involved in the preparations for Keystone. Paul headed up abstract submissions, Aron and Julia participated in the planning meetings for the Plenary and invited speakers, and Aron reviewed abstracts for Terri and Paul. We also worked with several groups to submit presentations that were relevant to both collaborations. These included:

- Syntheses of non-randomized studies
- Qualitative research and its applicability to SR's
- Search strategies for the social sciences
- Process and Implementation issues for SR's

We are really hoping for a good showing at Keystone and the C1 organizers have been extremely accommodating.

### *Campbell Tool Box*

The ME is currently working to finish the update of previous review documentation in the tool box (estimated one week's work required to complete this task).

### *Collaboration with 3ie*

The SWG initiated closer collaboration with 3ie to ensure that Campbell guidelines (particularly regarding search strategies and search criteria) are considered in the early stages of the 3ie review process. The aim is to facilitate more timely transitions from a 3ie review to a Campbell review and to use resources as efficiently as possible.

### *Co-registration with C1 Groups*

Co-registration procedures are moving forward with the following Cochrane groups: Public Health, DPLPG, EPOC, and Drugs and Alcohol. A co-registration agreement describing principles and editorial procedures has been drafted to avoid parallel editorial process in both organizations and handle eventual 'worst case' scenarios where there are editorial disagreements between groups. Choice of editorial base currently rests with the lead review author (this has been a point of contention for one of the C1 co-coordinating editors and is currently under discussion). The agreement has been approved by Cochrane Public health Group (PHG). The PHG and SWG managing editors are currently piloting the agreement and drafting a set of practical procedures / steps for effectively and efficiently processing co-registered reviews.

The agreement has also been sent to Cochrane Drugs and Alcohol group and Occupational Safety and Health Review Group for comments.

### *Joanna Briggs Institute (JBI) Proposal*

This should be revisited. Last session, we approved (in principle) co-registered effectiveness reviews with JBL if they follow C2 protocol and we have editorial right of refusal. Progress on bringing qualitative synthesis into play in C2 is somewhat more complicated and appears to be stalled. Point of discussion for the group?



#### *OBSSR*

We're unsure of the progress with this endeavor.

#### *'Fast Track' Review Status*

The first title submitted by IMS was approved in May 2010 and the protocol will be submitted shortly. Our review process was very quick and our feedback helpful for making the review manageable within our timeframe. We now have until April 2011 for the completed review.

#### *Other News*

Last year's inauguration of the Leonard E. Gibbs Award was a great success and we plan to continue the award in the coming years. Betsy Gibbs, Len's wife, will contribute at least \$10,000 which would, with some additional fundraising, create an endowment for the award. Rather than fund raise every year, we would simply request payouts from an interest bearing fund. Question for the group: how do we mount a small fundraising campaign for this award?

Marc Winokur and David Albright have joined the SWG editorial board.

#### *Upcoming Presentations*

We will hold our annual interest group meeting at the Society for Social Work and Research (SSWR) annual meeting in Tampa in January 2011. The format will shift toward a systematic review interest group rather than a group solely focused on C2. Also, Aron and several members of the editorial board submitted two abstracts for the conference that involve the presentation of C2 reviews.

#### *Related activities*

SFI Campbell will be hosting C2 methods training at SFI Campbell, the Danish National Centre for Social Research in Copenhagen June 2010.

#### FUNDING NEWS

---

The C2 Crime and Justice Group is extremely grateful to have received external funding this year:

- National Policing Improvement Agency (NPIA), United Kingdom

The NPIA has generously provided the CCJG, through the Center for Evidence-Based Crime Policy (CEBCP) at George Mason University, with further funding of \$142,500 in addition to the \$420,000 provided last year for four systematic reviews and two systematic searches. The new funding will support the development of one of the systematic searches funded last year into a full review, as well as a new systematic review on



macro-level crime displacement. The funding also allows CEBCP to support the development and progress of these reviews through a post-doctoral fellow (Charlotte Gill) and David McClure, a doctoral student, who coordinate the project.

Since the previous progress report last May, four systematic review and two systematic search proposals on policing topics were accepted under the original funding plan and are in progress. They are:

1. Legitimacy in Policing (Lorraine Mazerolle and colleagues)
2. Spatial displacement of crime and diffusion of benefits (Kate Bowers and colleagues)
3. Effects of GIS (Larry Hoover and colleagues)
4. Interviewing and interrogation strategies (Christian Meissner and Allison Redlich)
5. Systematic search on policing in schools (Anthony Petrosino and colleagues) – complete
6. Systematic search on stress management for police officers (George Patterson and Irene Chung) – to become full systematic review.

---

## OTHER C2 CRIME AND JUSTICE GROUP NEWS

---

▪ CCJG Co-Chair David Weisburd is the 2010 Stockholm Prize winner.

Professor Weisburd won the prize for his work on crime displacement and diffusion of benefits in “hot spots.” The award will be presented on June 15, 2010 at Stockholm City Hall, Sweden. Professor Weisburd is the third CCJG member to win the Stockholm Prize. Jonathan Shepherd shared the prize in 2008, and Friedrich Lösel shared the inaugural prize in 2006.

▪ 10<sup>th</sup> Annual Jerry Lee Symposium on Crime Prevention

The 10<sup>th</sup> annual Jerry Lee Symposium was held at the University of Maryland and on Capitol Hill, Washington, DC, on April 19-20, 2010. The first day of the Symposium was aimed at an academic audience, and featured presentations on issues and controversies in evaluation research, including a discussion of the role of qualitative fieldwork in the development of evidence-based practices, and a discussion around “what is evidence-based crime policy and what needs to be done to support it.” Day 2 attracted practitioners and policymakers, and featured presentations and discussion on CCJG systematic reviews of drug substitution programs (Martin Killias – presented by David Wilson as Martin was unable to attend due to the volcano travel disruption) and formal processing of juveniles (Anthony Petrosino). The presentations were followed by a roundtable discussion of senior U.S. policymakers on the topic of “pulling federal levers to further evidence-based approaches – what’s possible and what’s not,” moderated by the honorable Laurie Robinson, Assistant Attorney General, Office of Justice Programs.

▪ Development of the CCJG Steering Committee

The CCJG Steering Committee voted on new co-chairs in February 2010. Peter Grabosky is to stand down as co-chair in November 2010. He will be succeeded by Martin Killias. David Weisburd will extend his term as co-chair to smooth the transition. He will be succeeded by David Wilson in November 2012.

The Steering Committee is also seeking a Spanish-speaking representative, as our current representative, Vicente Garrido, is to step down. Two nominations have been received and reviewed by the Steering Committee, and both candidates have been shortlisted for a vote at the June meeting in Stockholm.

### **Editor's Report**

Since taking over as editor of the Education Coordinating Group in early 2010, nearly all authors have been contacted regarding the status of their projects. Most have responded to my enquiries. Some authors are frustrated with the lengthy editorial process and are unlikely to continue; others are willing to continue the process with the new editor. At the beginning of 2010, there was a backlog of outstanding projects and I have endeavored to move as many of these through the process as possible.

In terms of specific activities since taking over as editor, the external review process on two systematic reviews has been completed. Three additional reviews are currently under peer review, one that was begun under the previous editor and two that were submitted to the current editor. In addition, one protocol has been accepted. Three protocols have been revised by their authors and are awaiting the editor's final review and approval. Five protocols had been through the external review process with the previous editor and are in the hands of their authors for revision. It is unlikely that more than two of these five will ever be resubmitted. Two new protocols have been received since February, 2010. One protocol is under external review and one has been reviewed by the editor; it is back with its author for revision prior to peer review. Three new titles have been received in 2010: two have been approved and the third is back with the author for minor revisions. Overall, there are seven approved titles and two titles under review. It is expected that five of these will result in protocol submissions.

Unfortunately, the two systematic reviews that are closest to completion are likely to be withdrawn. Upon receiving referee comments and the editor's action letter, both authors elected not to revise their manuscripts. One author had already submitted the review to another journal and the other author felt that the revisions requested by the editor and external referees were too extensive.

#### *Future Directions*

With the appointment of new co-chairs Paul Connolly and Gary Ritter, the Education Coordinating Group is revitalized for the coming year. The new leadership team in education has much to discuss to plan for the future growth of the Campbell Collaboration. From the editor's perspective, designing efficient systems to move systematic reviews through the publication process as quickly as possible will be a priority. In terms of expanding the influence of the Campbell Collaboration in both research and policy arenas, we need creative ideas for fundraising, recruiting new systematic reviews and reviewers, and marketing and promoting the work in progress. It will also be important to craft innovative ways to increase the capacity of education researchers who are interested in developing new systematic reviews.

## **Appendix 6: Secretariat report 2009**

### **Report on the secretariat of The Campbell Collaboration, 2009**

In March 2008 a new secretariat for the Campbell Collaboration was established within the Norwegian Knowledge Centre for Health Services in Oslo. The staffing complement is three full time positions. In 2009 there were two changes in personnel due to parental leave.

#### **The production of systematic reviews and reports**

More than 40 percent of all completed Campbell reviews have been published since the Oslo secretariat opened. A new online publication has been registered which includes all new reviews. Approved reviews are fully reformatted by us before publication.

In 2009, we published the following overviews:

1. Advocacy interventions to reduce or eliminate violence and promote the physical and psychosocial wellbeing of women who experience intimate partner abuse
2. Effects of drug substitution programs on offending among drug-addicts
3. Effects of parental imprisonment on child antisocial behaviour and mental health: a systematic review
4. Kinship Care for the Safety, Permanency, and Well-Being of Children Removed from the Home for Maltreatment
5. Prevention and intervention of cyber abuse targeting children and adolescents: A systematic review to evaluate current approaches
6. School-Based Programs to Reduce Bullying and Victimization

In September 2009, Campbell submitted two reports of particular relevance for Norwegian government agencies:

1. An overview of the "return to work" studies
2. A systematic review of the use of DNA by law enforcement investigators, commissioned by the Norwegian Ministry of Justice.

#### **Campbell's annual colloquium**

In May 2009, the secretariat organized the ninth annual colloquium in Oslo. The theme was "Better Evidence for a Better World". It gathered 245 participants, including 30 from developing countries. *The Lancet* magazine published an article describing the colloquium as a "radical and impressive gathering that promised new ways to address urgent issues in health and social care today."

The secretariat arranged two meetings of the Steering Group, in Oslo in May and in Washington DC in October.

### **Website and library**

The secretariat managed and developed the redesigned website and concluded the restructuring of the online library, which incorporates Campbell Systematic reviews as an online publication.

### **Reference Group**

The secretariat services a Reference Group set up by the Ministry of Education, whose function is inter alia to identify issues of relevance for Norwegian agencies that can be addressed by systematic reviews.

### **Briefings**

The secretariat has arranged numerous briefings for policymakers and practitioners on specific topics, taking the opportunity to draw on the expertise within the Campbell network.

### **Networking**

The secretariat has sought to build relations with other actors in the field of evidence-informed policy, including like-minded bodies in Copenhagen and Stockholm and EPPI-centre in London; we are a partner in an EPPI-centre led project on evidence for education in Europe. Particular importance is attached to cooperation with the Cochrane Collaboration.
